Things You Should Know

PAY RAISE

There will be a 1.2% wage increase on November 21, 2009 that will appear in your December 11, 2009 paycheck.

WEINGARTEN RIGHTS

The parties have agreed that our members are entitled to union representation during an investigatory interview which the employee reasonably believes may lead to discipline.

This right must be asserted by the member at the time of the interview and is not an assumed right. If you don't ask they won't offer.

The Weingarten rule also includes the right to a pre-interview consultation with a steward, prior to meeting with management, inspection service or OIG inspector.

The employee has the right to a steward's assistance, not just a silent presence, during an interview covered by Weingarten. Your rights are violated when the union steward is not allowed to speak or is restricted to the role of a passive observer.

COOPERATION IN INVESTIGATIONS

Section 665.3 of the ELM states: "Employees must cooperate in any postal investigation, including Office of Inspector General investigations."

To invoke your Weingarten rights you must reasonably believe that the interview may

lead to discipline.

Cooperating in an investigation doesn't require a written statement. You can answer questions or provide a narrative of what occurred, but nothing requires you to make a written statement.

EMPLOYEE SURVEYS

The position of our national union is that we don't participate in employee surveys. I'm not sure if anyone has ever explained the reasons for taking this position.

I have attended a number of national contract negotiation sessions. And without fail the USPS has relied on the results of the survey to influence our wages and working conditions.

They use the results to demonstrate to the arbitrator that we are happy and don't need raises. I'm not kidding, it really happens. Your responses on the survey are used against all of us during contract arbitration.

PROGRESS WITH THE POSTAL ACT OF 2006

In a presentation given on November 18th by Patrick Donahoe, Assistant PMG to the highest levels of postal management the following numbers jumped out at me:

WORKHOUR REDUCTIONS in FY09

Total Workhours (WH) 115million
Mail Processing WH 42 million
City Delivery WH 28 million
Customer Service WH 25 million
Administrative WH 6 million
(Administrative & General Management)

Note: The smallest reduction was in management!


