

Privatization of the Postal Service / Mid Term Elections

Privatization of the postal service is what this current congress is pushing for, this will be a battle that requires all members to stand up, unite and fight. Information is first and foremost, not just members but all employees of the postal service need to reach out and inform the public of what is taking place in the postal service. Explain to your family members, your friends and anyone you come in contact with the financial effects of the Postal Reform Act of 2006. We need to speak out about the understaffing that is taking place in the plant and how it affects the delivery of their mail. The mail being delivered from the processing facility to your local post office delays the time the carrier can leave out on his route, which delays the time in which the customer receives their mail at their residence. Explain how not supplying the window clerk with stamps and referring customers to another business to purchase stamps is done by the decisions that management is making. In Charlotte over the last three years 12 local post offices have had their hours reduced in the evening from 6:30 p.m. to 5:00 p.m. This has a bearing on the small businesses in the area. They rely heavily on the mail stream, where they would close at 5:00 or 5:30 and still get their mail into the mail stream on that day, they now have to wait until the next day. This is a delay to their business.

We are approaching the mid-term elections. We need everyone to vote, your vote counts. We ask that you vote on the entire ballot. There are some amendments on the ballot this year. We ask that you vote against these amendments. They are attempting to take us back 50 years as for as a democracy. I will speak on a couple of those amendments. Judicial Vacancy Appointment Amendment - This is Legislative takeover of the Governor's power to decide whom to appoint to fill judicial vacancies. The amendment provides few details on how the so called "merit commission" would be assembled or who would have a say, so voters wouldn't know these critical details of the process before casting their vote. This proposal threatens the separation of powers in our government by dramatically changing the power legislators have to control who sits on our state courts, a slippery slope that amendment sponsors said could lead to voters losing the ability to elect judges altogether.

Step 1 TIME LIMITS

The fourteen days for filing a grievance at Step 1 begins with the date of the occurrence or the date when the grievant or the union may reasonably have been expected to have learned of the occurrence. For example, when an employee receives letter of warning, day one of the fourteen days is the day after the letter of warning is received.

ELM Section 436 does not extend the time period of filing grievances but, rather, places a six-year limitation on the time during which an employee must submit a settled claim to the appropriate authority for collection.

Dear Postal Worker Sisters and Brothers:

Together we can use our voice and our vote to make our state and our country better places for working people. Right now, too many of us are working too hard for too little, and federal workers like you must constantly fight against efforts to downsize and privatize government services. But the good news is that it doesn't have to be this way. By electing candidates who are committed to good jobs and higher wages, we can ensure that working people get our fair share.

Together we can make a difference, so I urge you to vote. Early voting is available from October 17 through November 3. Contact your county Board of Election for a list of early voting sites. Polls will be open from 6:30 AM to 7:30 PM on Election Day, November 6.

How you vote is a personal decision, but I hope that you will consider supporting laborendorsed candidates. Representatives from your local union and the state's labor movement have talked with these candidates and researched their positions on issues that affect our jobs, our wages, and our union rights. We base our endorsement on policy positions not political party. We believe our endorsed candidates will fight to protect our jobs, our retirement security, and our rights as workers, voters, and consumers.

I hope you will help educate your fellow union members about our endorsed candidates and what's at stake in this election. It is important that folks vote on the entire ballot including the judicial candidates and the constitutional amendments. Our courts are a backstop to the discriminatory laws we've seen recently from our state legislature. We are proud to support Anita Earls, for state Supreme Court. As executive director of the Southern Coalition for Social Justice, Anita led the lawsuits challenging racial gerrymandering and voter suppression. In addition to the Supreme Court race, there are three seats on the state Court of Appeals on the ballot. We are supporting John Arrowood, Allegra Collins, and Toby Hampson for those seats.

Please don't forget to vote for the judges or against the misleading constitutional amendments that are on the ballot. More information is enclosed about the amendments we oppose.

Let's use our vote to make positive change for working people. And after this election, let's hold our elected officials accountable and let's keep agitating, organizing, and fighting until there are good jobs and fair wages for all workers.


