Penalty Overtime & Leave Year

The exclusion period for penalty overtime is December 4-31, 2010.

The new leave year begins January 1, 2011.

Local Negotiations

If we end up with a negotiated contract then local negotiations could be as soon as March 2011. Obviously if we go to arbitration then negotiations will be delayed for months.

We will begin planning for negotiations now. You can review your LMOU for your office by going to our local web site. Are there things you would like to see added or deleted from your LMOU?

Over the next couple of months we will be reviewing each and every LMOU to see if we can improve on what we already have. Article 30 of the CBA list the 22 items for which we can negotiate locally.

I have personally negotiated over 30 prepared and to put together a great negotiating team. By starting early we will have an opportunity to really dissect each LMOU and look for ways to improve on them where needed.

Contract Negotiations

President Burrus has reported that contract negotiations are going very slow and little progress lay-off clause and wages.

There are sub committee meetings being held to discuss numerous issues, but these discussions are almost always off the record. The fact that we will change our national president with eight days remaining before the expiration of the contract may delay serious conversations.

Open Seasons

Open season for Health Benefits, Dental & Vision Plans and Flexible Spending Accounts is November 8 thru December 13, 2010.

Premiums for the 2011 FEHB Program will rise by an average 7.2% for the enrollee share of premiums. This increase is below last year's premium increase of 8.8%. There are 207 health plan options in the FEHB Program for 2011.

PMG Potter to Retire

PMG Potter has announced his retirement and he will be replaced by Patrick Donahoe who is currently the Deputy PMG and Chief Operating Officer. It has already been announced that two people will replace Mr. Donahoe.

Every job that becomes vacant in our crafts separate LMOU's for small offices, large offices and is seriously looked at for the possibility of reverting a mail processing plant. The key to success is to be the job. Not in the ivory tower they call postal headquarters, they want to add a job and not a cheap job at that. Mr. Donahoe makes \$251,000.00 in base salary not counting his bonuses.
